Actions arising from the last meeting:

There were a number of actions from the last meeting which include:

Wood Path – spread of chippings. Tony Lyle to organise when Jack Stone has driven down path to remove any trip hazards – this will be in the Spring.

Hall Car Parking

As we have possibility of funding available, action needs to be taken and plans made, in order to confirm our intentions. All Committee to find out as much info as possible and come up with ideas as to how additional parking could be dealt with. Nick Rowell and GA have been in discussion about possibilities and Nick will come up with ideas / costings. David French has a drone camera – GA to contact – to have an aerial picture of the land immediately surrounding the Hall – better than Google Maps which are out of date in this area.

Permissive Path

GA had been in touch with Devon CC regarding the permissive path (Village Access Path and the Cumber Close Entrance onto the Playing Fields). DCC are not considering any new formal agreements for permissive access at this time but the contact states:

We can have an informal arrangement where DCC is not involved. The path can be closed for one day per year thereby preventing 'uninterrupted use as of right' from accruing. It is important to maintain documentary evidence if this is to stand up in a court of law.

MVH can erect permanent signs identifying that the route in question is used 'by permission' and not 'as of right'.

Gas Meter Rates

Following a query by JM regarding the gas rates for hirers using the coin meters, Geoff Allen undertook a test whereby it was found that the Annexe Gas Meter (which is primarily installed as a charging mechanism) is not accurately recording the volume of gas although it is in fact charging correctly. However, the Certified Main Gas Meter in the Main Hall is correct and this is where the information is taken from to bill us. No further action at this time.

Outdoor Gym

The Parish Council has 4 contractors supplying quotes for the installation of outdoor gym equipment on MVH land. These are currently under review and assessment in order to make the correct decision. GA to advise when further details are known.
