#### Secretary's Report (TC):

The secretary apologised for the errors in the first edition of minutes of the meeting dated 13<sup>th</sup> of February, which was subsequently corrected. No further report.

#### Sports (JJ):

A proposal was discussed to waive the charge for the use of the tennis courts for Malborough residents in order to try to encourage more use of the tennis courts. After detailed discussion it was felt that the

administration of such a scheme and the difficulty of distinguishing between residents and visitors would make the matter impractical and would not be pursued further.

KMFC have advised that they anticipate running the same number of teams next year as in previous seasons. It was proposed that the charges be increased by approximately same percentage as charges for all other facilities, and JJ will issue a new invoice reflecting this increase.

### **Booking Officer: (VJ)**

The Queen tribute night was a great success but due to lack of support the Murder Mystery evening due to take place on 16th of March has been cancelled.

Regarding the Horticultural Society Shows, the exercise class which clashed with the August dates has now been cancelled, but not the one for September. The organisers of the Horticultural Society Show will be advised of this compromise and our offer of assistance for the September show will be repeated. The Gilbert and Sullivan concert has been confirmed for 13th July.

## 6. Projects

#### a. Car Parking

FIT have agreed that we can have three disabled spaces and an unloading area in front of the Hall and that the current overflow area to the east of the hall may be resurfaced in GOLPLA. The contractor, Landmarc, is providing costings for the defined areas. The delays are caused by the contractor working currently in Stockport, but he has been chased for the information. A meeting took place between SHDC and the contractor to discuss a request from SHDC regarding the GOLPLA specification (which was detailed on the plan submitted to the SHDC engineer).

#### b. Fire doors

Following discussion and agreement at the committee meeting of the 13<sup>th</sup> of February, Avon Windows Ltd of Kingsbridge have been instructed to supply and fit new doors to the north end of the Annexe, replacing the wooden doors which are rotten. In addition, they will carry out repairs to the damaged window in the main hall. It is anticipated that this work will be completed by late March/early April.

#### d. Ladies' and Disabled Toilets refurbishment

#### e. CCTV

One camera is waiting replacement, together with a new backup recording facility.

#### f. Hall curtains/blackout

An application to Tesco 'bags for help' to assist with this project has been rejected, despite assurances from our Community Champion that we should apply. Apparently application rates are very high in our area and we have previously received funding.

An application has now been sent to Wales and West to see if our project is suitable for their charity funding programme.

# g. Grandstand/gang mower store

Further details on Tony Lyle's quotation for a store are awaited.

## 7. Any other business

- a. Stanborough Choruss will be holding a concert at the hall on 16 June.
- b. The Co-op collection towards the provision of Wi-Fi in the hall for our hirers is coming along nicely and we should have the final result by early summer.
- c. John Butler's daughter Hannah, will take over the organisation of Bonfire Night for this year, and will contact us again after April.
- d. Summer Fete: there has been a poor response from villagers to the invitation in the latest edition of the Malborough Messenger for villagers to come forward with plans and ideas for displays, stalls and games at this year's Summer Fete on 22 June. It is hoped that a further appeal may bring forward more positive results. In addition, identified local artisans and craftspeople will be approached with an invitation to come along. As this is the 150th anniversary of RNLI Salcombe lifeboat they will also be invited to have a stand.
